Eligible entrants:	Entry is only open to QLD residents who are 18 years and over.	
How to Enter:	For each day of the Promotional Period, a new promotional post will be published by Brisbane Airport on the Skygate Brisbane Facebook Page (www.facebook.com/skygatebrisbane) at approximately 9am AEST. To enter a draw for a specific day, the entrant must comment on the promotional post published that day by 11.59pm AEST the same day . A different prize is available to be won for each draw/promotional post. The promotional post will specify any requirements for the comment (e.g. answering the question listed, tagging a friend, etc).
